1. That The Kalgidhar Trust, Baru Sahib (H.P.) is a registered Trust as per the provisions of The Registration Act, Vide Registration No. 5/2019, Dated 27.02.2019.
2. That The Kalgidhar Trust, Baru Sahib (H.P.) is of Non-Proprietary Character.
3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the Institution is being and will be diverted to any individual in the Trust/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same school only.

6. That the school will not open classes under C.B.S.E. pattern particularly class IX/X/XI/XII and will not use C.B.S.E. name in any manner without obtaining affiliation.
7. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the Affiliation & Examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the Affiliation & Examination bye-laws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety and Sanitation certificates are being issued or renewed by the concerned Municipal or State authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
