The school all labs needs to be enriched with more equipment's & etc. further, the labs equipment, reagents and specimens etc. kept in laboratories shall be in accordance with the laws, rules and regulations applicable. 3. The school is required to appoint one Special Educator as per rule 13 (11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015. 4. One Wellness Teacher (counsellor) is required to be appointed. 5. The school is required to appoint more trained & qualified teachers to maintain section/teacher ratio 1:1.5 as per norms of the Board. 6. The enrolment should be restricted with optimum number of 40 students per section as per norms of the Board. 7. The school is required to ensure time to time renewal of all mandatory safety certificates.
